The University is conducting classes for debarred students of **I Semester** and **III Semester** for batch 2011 and students of **I Semester** for **batch 2012** (All Courses) from **13th January, 2014**.

All such students are directed to submit fee of Rs 1000/- per theory/practical subject, in the Examination cell by **31st December, 2013** and then report to concerned HOD.

Attendance of the students in debarred classes will be counted from **13th January, 2014** and they will have to ensure 70% attendance in these classes to allow them to appear in back papers.

An affidavit (format attached) duly notarized must be submitted in the Examination Cell at the time of registration for debarred classes.
